**APPLICATION FOR FELONY TERMINATION OF REVOCATION for
FELONY DUI LIMITED LICENSEES**

On July 1, 2016, the legislature enacted additional laws allowing a driver, whose privilege to drive was revoked permanently following a conviction for felony Driving Under the Influence (DUI), to apply for a felony DUI limited license IF they had successfully completed a court-ordered treatment program under AS 28.35.028 or a rehabilitative treatment program under AS 28.15.201(h). The department shall review the driver's license revocation imposed under AS 28.35.030(n)(3) and shall restore the driver's license if they have met the criteria under AS 28.35.030(o)(2).

SUBMISSION CRITERIA

This law only applies to drivers convicted on or after July 1, 2002 under AS 28.35.030 (n)(3) and who are eligible for a termination of revocation under AS 28.35.030(o)(2).

SUBMIT this application if you meet the following criteria:

- The person **must** have been granted a limited license under AS 28.15.201(g) and successfully driven under that limited license for 3 years.
- The person **must** have also successfully completed a court-ordered treatment program under AS 28.35.028 or a rehabilitative treatment program under AS 28.15.201(h).
- The person **has not** been convicted of a violation of AS 28.35.030 or 28.35.032 or a similar law or ordinance of this or another jurisdiction **since the license was revoked**.

DO NOT SUBMIT this application if:

- Your felony offense(s) occurred before July 1, 2002;
- You have been convicted of a violation of AS 28.35.030 or 28.35.032 or a similar law or ordinance of this or another jurisdiction since the license was revoked.

All sections of this application must be completed and all required documents in Section B must be attached. Applications not meeting submission requirements will not be processed. Once your application is accepted, your criminal record and driving record will be reviewed for eligibility. Pending alcohol or driving related court cases may delay the review. If your application for termination is approved, you will be notified of your reinstatement requirements.
