Please submit this signed release form, with photograph(s), to your local DVS exam station and/or to the Crash Victims Memorial Wall in Saint Paul, MN. (Addresses on back.) Photographs may be displayed in one or both locations.

- Behaviors such as operating a motor vehicle while impaired by alcohol or drugs, traveling at unsafe speeds, and engaging in aggressive and distracted driving cause hundreds of deaths and thousands of injuries annually on Minnesota roads.
The Crash Victims Memorial Wall project, developed by the Minnesota Department of Public Safety, reminds us that traffic safety does matter. Driver and Vehicle Services driver's license exam stations throughout Minnesota have dedicated wall space for communities to commemorate crash victims.
To contribute a photograph to the Crash Victims Memorial Wall:
- Select a photograph (preferably with dimensions of 4" by 6" or 5" by 7") and place it in a simple frame of your choice.
- If you wish, you may insert inside the frame a brief - neatly written or typed - statement about the person in the photograph.
