49 CFR Part 391 Qualification Requirements

If you will not meet the following federal qualification requirements, you may not operate a commercial motor vehicle in nonexcepted interstate commerce but may be eligible to operate in interstate excepted commerce and/or intrastate commerce.

Part 391.11 – General qualification of drivers.

- (a) A person shall not drive a commercial motor vehicle unless he is qualified to drive a commercial motor vehicle. Except as provided in Part 391.63, a motor carrier shall not require or permit a person to drive a commercial motor vehicle unless that person is qualified to drive a commercial motor vehicle.
- (b) Except as provided in subpart G of this part, a person is qualified to drive a motor vehicle if he/she:
 - (1) Is at least 21 years old;
 - (2) Can read and speak the English language sufficiently to converse with the general public, to understand highway traffic signs and signals in the English language, to respond to official inquiries, and to make entries on reports and records;
 - (3) Can, by reason of experience, training, or both, safely operate the type of commercial motor vehicle he/she drives;
 - (4) Is physically qualified to drive a commercial motor vehicle in accordance with subpart E—Physical Qualifications and Examinations of this part;
 - (5) Has a currently valid commercial motor vehicle operator's license issued only by one State or jurisdiction;
 - (6) Has prepared and furnished the motor carrier that employs him/ her with the list of violations or the certificate as required by Part 391.27;
 - (7) Is not disqualified to drive a commercial motor vehicle under the rules in Part 391.15; and
 - (8) Has successfully completed a driver's road test and has been issued a certificate of driver's road test in accordance with Part 391.31, or has presented an operator's license or a certificate of road test which the motor carrier that employs him/her has accepted as equivalent to a road test in accordance with Part 391.33.

Part 391.13 Responsibilities of drivers.

In order to comply with the requirements of Part 392.9(a) and § 393.9 of this subchapter, a motor carrier shall not require or permit a person to drive a commercial motor vehicle unless the person:

(a) Can, by reason of experience, training, or both, determine whether the cargo he/she transports (including baggage in a passenger-carrying commercial motor vehicle) has been properly located, distributed, and secured in or on the commercial motor vehicle he/she drives;

(b) Is familiar with methods and procedures for securing cargo in or on the commercial motor vehicle he/she drives.

Driving Type	Description			
Non-excepted interstate	Driver operates or expects to operate a CMV in interstate commerce and driver is subject to, and will meet, the qualification requirements of 49 CFR part 391 (shown above), including medical qualifications. Most CMV operation is "non-excepted interstate". If you qualify , DMV recommends you certify non-excepted interstate.			
Excepted interstate	Driver operates or expects to operate a CMV in interstate commerce but, due to exceptions under 49 CFR parts 390.3 (f), 391.2, 391.68 or 398.3, driver is not subject to all or part of the qualification requirements of 49 CFR part 391 (shown above) and is not required by FMCSA to meet federal medical standards. Some examples of excepted interstate operation are school bus operations, transport by government entities, some farm operations, and bee transportation. Driver must still meet medical qualifications for issuance of an Oregon CDL. When operating a CMV in transportation that is non-excepted, you will be restricted to intrastate commerce only.			
Non-excepted intrastate	Driver operates or expects to operate a CMV in intrastate commerce only and is not subject to the qualification requirements of 49 CFR part 391 (shown above). Driver must still meet medical qualifications for issuance of an Oregon CDL. You may also operate a vehicle in excepted interstate commerce.

CDL Renewal

If you are applying to RENEW a CDL:

You must have on file with DMV or submit a valid and approved medical certificate and have a valid medical waiver or exemption if the medical certificate indicates such document is required to meet CDL medical qualifications. If you are unable to meet the medical certification requirements, you have the option to downgrade your license by completing Section D on the front of this form.

If you are applying to renew a CDL with a hazardous materials endorsement:

You must have a notation recorded on your OR DMV record of having passed a background check by the Transportation Security Administration (TSA) within the previous 5 years. The TSA agent has fingerprint collection locations in most states but none located outside the United States. Please call 1-855-347-8371 or visit the website at http://www.tsa.gov/for-industry/hazmat-endorsement to submit application and fees and to identify fingerprint locations and hours of operation. You must have a passing hazardous materials endorsement knowledge test score on file with DMV. Knowledge test scores are valid for six months. If you are unable to meet the background check or knowledge test requirements you have the option to remove the hazmat endorsement from your CDL by completing Section D on the front of this form.
