□ 1.	Complete the enclosed application and answer all the questions, if applying for a driving privilege.
□ 2.	Sign your name in the box marked with the "X".
□ 3.	Sign your name in the box at the bottom of the application.
□ 4.	Complete the Valid with Previous Photograph Proof of Good Cause/Waiver form (735-7359).
□ 5.	Provide proof of being a U.S. citizen, lawful permanent resident of the U.S. or citizen of a nation that is part of the Compact of Free Association (COFA). For a list of acceptable documents, see the Identification Requirements brochure included with the application packet. *Military service members and dependents – see the back of this form for additional information.
☐ 6.	Provide proof of current residence address. (Renewal only)
☐ 7.	If you are 50 years of age or older and renewing your driver license or driver permit, have a licensed vision specialist complete the Certificate of Vision and return with your application.
□ 8.	Complete the Certification of Oregon Residency or Domicile form and return with proof, such as an Oregon permanent or part-year income tax return filed with the Oregon Department of Revenue for the previous tax year. Nonresident forms are not acceptable. If you are an active duty military service member or the dependent of a military service member, your or the service member's most current Leave Earning Statement (LES) noting Oregon as home of record (HOR) is acceptable proof. A full list of acceptable proof is on the back of the form. (Renewal only)**
□ 9.	Submit a check or money order payable to DMV for the correct amount noted below. NOTE: If your current license, permit, or ID card expires in a year or less you may renew.

ADDING A MOTORCYCLE ENDORSEMENT You must apply for a motorcycle endorsement within two years from when you complete the course, unless the course completion card expires sooner. ☐ Have a licensed vision specialist complete the **Certificate of Vision** form and submit with your application. ☐ Submit an approved Motorcycle Rider Education Course completion card (front and back). These courses are approved by DMV: • Motorcycle Safety Foundation (MSF) Basic Rider motorcycle rider education course; Idaho Skills Training Advantage for Riders (STAR); California Motorcyclist Safety Program (CMSP) Motorcyclist Training Course; Total Control Riding Clinic; and • Motorcycle Ohio Rider Enhancement (MORE). MILITARY SERVICE MEMBERS AND/OR DEPENDENTS ONLY Complete numbers 1-9 on the front of this form and provide: ☐ A copy (front and back) of your military ID. If you are a dependent of a military service member submit a copy of your military ID and a copy of the service member's military ID. Military ID is an option; not mandatory. If you do not want to submit a copy of the military ID card, you can choose another acceptable proof document listed in OAR 735-062-0020. Check www.oregondmv.com for a list of other options for proof of identity and date of birth. ☐ If you have had a name change, proof of legal name change is required. Proof can be a court ordered legal name change, marriage certificate or divorce decree.* **COMMERCIAL DRIVER LICENSE (CDL)** Submit a copy (front and back) of your current medical card with your application. ☐ If your CDL contains a hazardous materials endorsement, you must take a hazardous materials knowledge test and have a criminal background check done with Transportation Security Administration or you can complete the Surrender of Driving Privilege(s) form and submit with your application. You must mark the "I am surrendering: My CDL" and fill in Hazmat Endorsement. *To take the hazardous materials knowledge test you must visit your local Oregon DMV office. TEMPORARY PERMIT If you asked for a temporary permit, it is enclosed. Sign it and keep it with you when operating a vehicle. The permit is your proof of driving privileges until you receive your license in the mail.
