If you wish to replace a regular personalized plate you already own with a personalized Ducks Unlimited license plate, enter the number in the $1^{\text {st }}$ Choice block on the front of this form. However, if your existing personalized plate does not meet the criteria listed on this form, it cannot be ordered as a personalized Ducks Unlimited plate. (SEE NOT ALLOWED BELOW)

Individual requests for personalized plates received each month are compiled into an order, which the department sends to the factory on the first working day of each month. The plates are normally available within ten (10) weeks after the order is placed. You will be notified by mail when your plate is available with instructions as to what you must do to receive it.

- The issuance of personalized Ducks Unlimited license plates is restricted to passenger cars, $1 / 2$ and $3 / 4$ ton pickups, and 1- ton trucks used only for private transportation. They may not be issued to 1-ton trucks used for commercial purposes.
- Personalized Ducks Unlimited plates may consist of not more than five (5) characters and spaces combined.
- Personalized Ducks Unlimited plate numbers may not conflict with the regular numbering system of regular Ducks Unlimited plates, or the number system of any regular license plate. The numbering system for the first 150 regular Ducks Unlimited plates is 001 through 150. The numbering system for the remaining regular Ducks Unlimited plates consists of 1 numeric followed by 4 alpha characters.
- Requests for personalized Ducks Unlimited plates must be on the form approved by the department.
- The fee for personalized Ducks Unlimited plates is $\$ 20.00$ annually in addition to the regular registration fee, the $\$ 10.00$ special fee, and the $\$ 25.00$ Ducks Unlimited design use fee.
- Notification will be sent by mail when the plate is available. You should allow eight (8) weeks for plate manufacturing before inquiring as to the disposition of your order.
- Applicants may request three (3) combinations in priority of $1^{\text {st }}, 2^{\text {nd }}$, and $3^{\text {rd }}$ choice as listed on the front of this form. The $1^{\text {st }}$ choice will be ordered if available, if not the second choice, etc. If non of the choices are available, the fee and application will be returned to applicant.
- The owner must sign this form, or if jointly owned either may sign.
- After a choice has been submitted and accepted by this office with the $\$ 20.00$ fee, there can be no change or refund of fee.


## NOT ALLOWED

1.Combinations of characters that conflict with any numbering system developed by the department.
2.Words of letter combinations that are offensive, suggestive, or not in good taste, as determined by the department.
3.The use of symbols and signs such as period (.), plus sign (+), dash (-), etc.
4. A duplicate of any license plate number.
5.Any combination exceeding five (5) characters and spaces combined.
6.Any number beginning with 001 through 150.
