



AFFIDAVIT IN LIEU OF CERTIFICATE OF TITLE FOR A SALVAGE OR JUNK VEHICLE BY A SALVAGE DEALER

This form is *only* to be used by salvage dealers who are licensed under the Illinois Vehicle Code who is in possession of a vehicle pursuant to a request by an insurance company that is licensed under the Illinois Insurance Code. Registration *is not* to be issued to the vehicle below.

In addition to this affirmation, the applicant **shall submit** (i) a paper application for title (VSD 190 form) for a salvage or junk title (**ERT applications will not be accepted at this time**); (ii) proof of request by an insurer as to the possession of the vehicle by the salvage dealer; (iii) an official record search by the Secretary of State for the owner of the vehicle and/or any lien holder on record; (iv) written notice, including proof of service (certified mail, service process), to the owner and/or lien holder that an application for title will be made on the salvage dealer's behalf, at least 30 days after the date of the application for title, based on the a denial of an insurance claim and the vehicle owner's and/or lien holder's inaction to redeem the vehicle within 45 days of the notice sent unless the payment of applicable charges has been made to the salvage dealer; and (v) any applicable fees and/or taxes.

The Secretary of State reserves the right to request additional documentation to ensure that any owner/lien holder is made away of the transfer of ownership to the salvage dealer prior to the processing the application for certificate of title pursuant to Section 3-117.3 of the Illinois Vehicle Code.

CERTIFICATION

I, _____ (please print), am authorized to sign this document on behalf of the applicant salvage dealer identified above and I certify and affirm that all the information presented in this form and any accompanying documents are true, correct and genuine. I certify and affirm that: (i) I have provided documentary evidence indicating the insurer has denied a total-loss claim to the former owner of the vehicle; (ii) notice has been provided to the owner and lien holder, if any, as to the transfer of title; (iii) the salvage dealer has not been able to obtain the Certificate of Title from the owner; and (iv) I have provided legible copies of written attempts to contact the vehicle's owner at the owner's last known address at least 30 days ago, based on both the insurer's records and the Illinois Secretary of State vehicle records.

I understand that this affirmation is only to be used when a motor vehicle has been issued a title in Illinois; the owner and/or lien holder has been denied compensation from the insurer; the insurer is licensed under the Illinois Insurance Code and authorized the applicant to take possession of the vehicle prior to the denial of the claim; the salvage dealer is unable to obtain the certificate of title from either the owner or lien holder; and neither the vehicle owner or the lien holder has sent notice of dispute within 30 days after the notice of transfer was sent.

I understand that I am making this affirmation under the penalty of perjury and that knowingly making a false representation on this form is punishable by law.
