The credit allowed is: <ul> <li>\$1000 for a 2-wheeled zero emission plug in electric drive or fuel cell electric motorcycle</li> <li>\$2000 for a 3-wheeled zero emission plug in electric drive or fuel cell electric motorcycle or auto cycle</li> <li>\$3000 for a zero-emission plug in electric drive or fuel cell electric motor vehicle</li> </ul> <li>I/we certify this vehicle is owned or leased by an individual(s) and an excise tax credit of this type has not been previously granted to me on another vehicle (if two qualifying electric vehicles are jointly owned by individuals, each person is entitled to receive an excise tax credit for one of the vehicles).
