

Non-resident's affidavit of intent to title vehicle in North Carolina

Purpose: Active-duty service members, their dependents, college and university students, and other non-residents who intend to garage/keep their vehicle in North Carolina for at least six months out of the year¹ may use this form to apply to title their vehicle in North Carolina without a North Carolina driver license. Vehicle owners not in one of these categories need a North Carolina driver license to title their vehicle.

The vehicle owner must provide a copy of their out-of-state driver license status when submitting this form. See Part 2: Owner information for required documents.
