- If a hyphen or space is used as part of the registration plate configuration, it counts as one of the available spaces for personalization. Only one hyphen or space is permitted, but not both. NOTE: No additional special characters are available.
- Please use capital letters and print clearly. When requesting a numeric character of zero, please show as " $\varnothing$ " instead of the alpha character "O." Since this is an electronically fillable form, after printing the form, please be sure any zero is marked with a "/."
- PennDOT reserves the right to limit or reject certain requests.
- Requests for personalized Street Rod registration plates are restricted to passenger cars or trucks with a registered gross weight of not more than 9,000 pounds.
- Registration on your vehicle must be current in order for PennDOT to process your request. The fee covers the cost of your personalized registration plate order only and will not renew your vehicle's registration.
